

**Fig. 1. RMS on-state current as a function of lead temperature; maximum values**



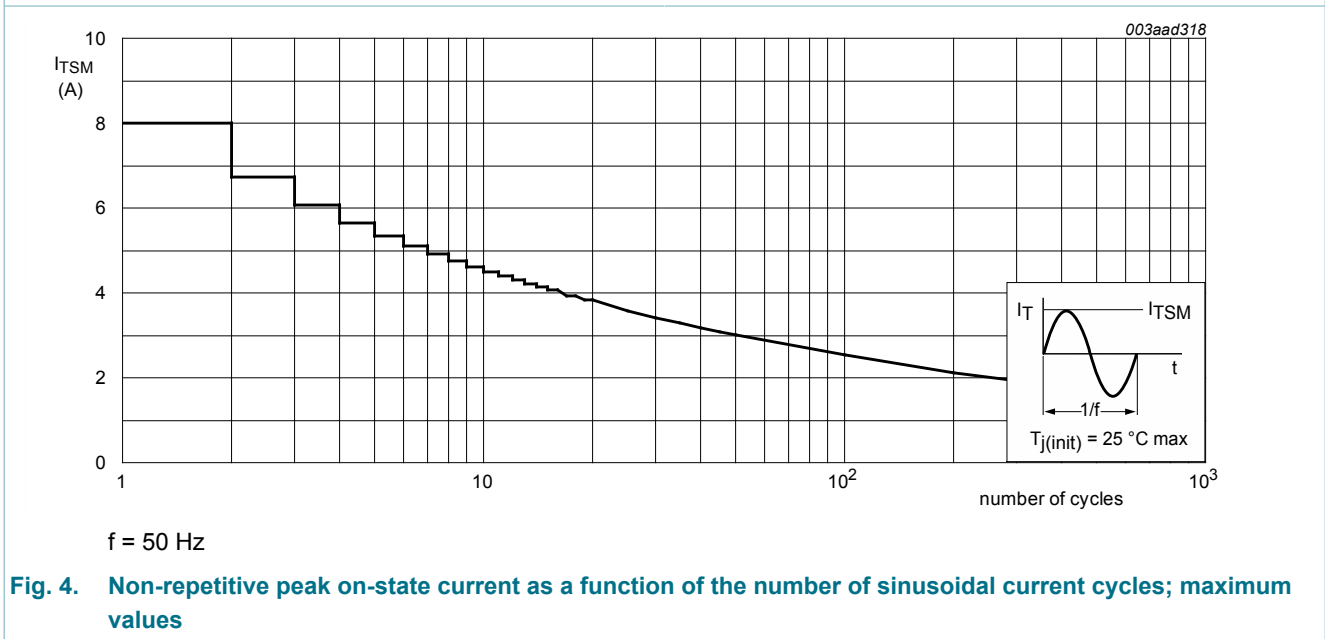
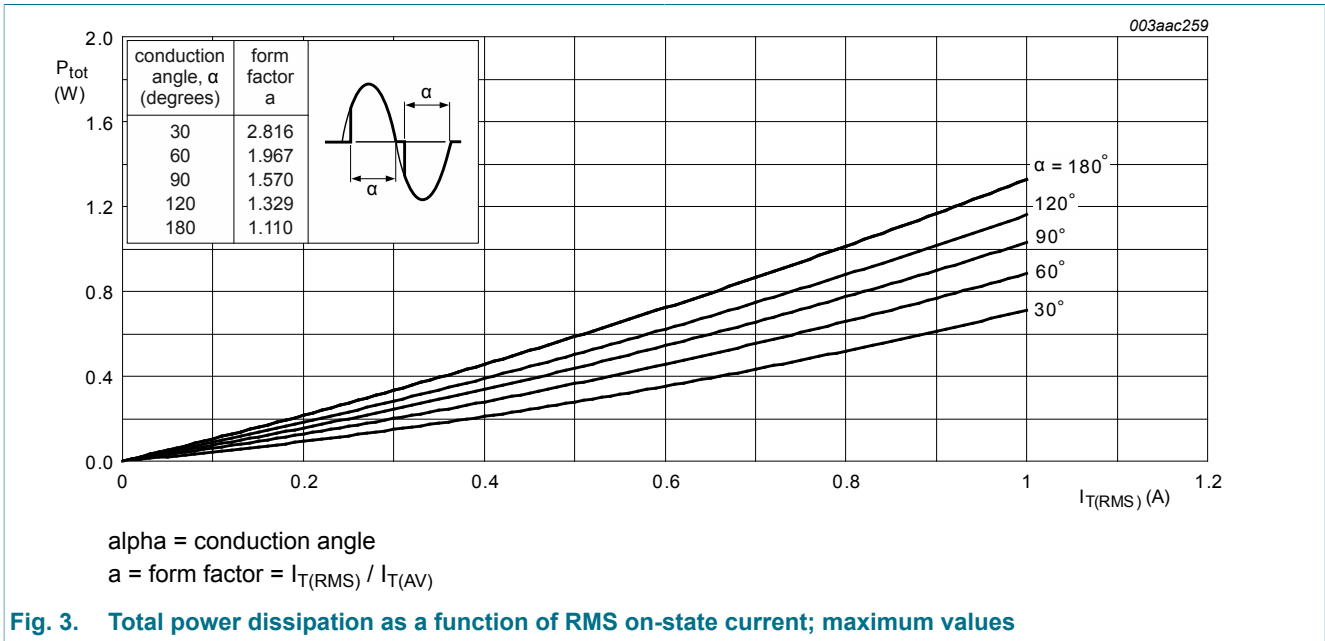

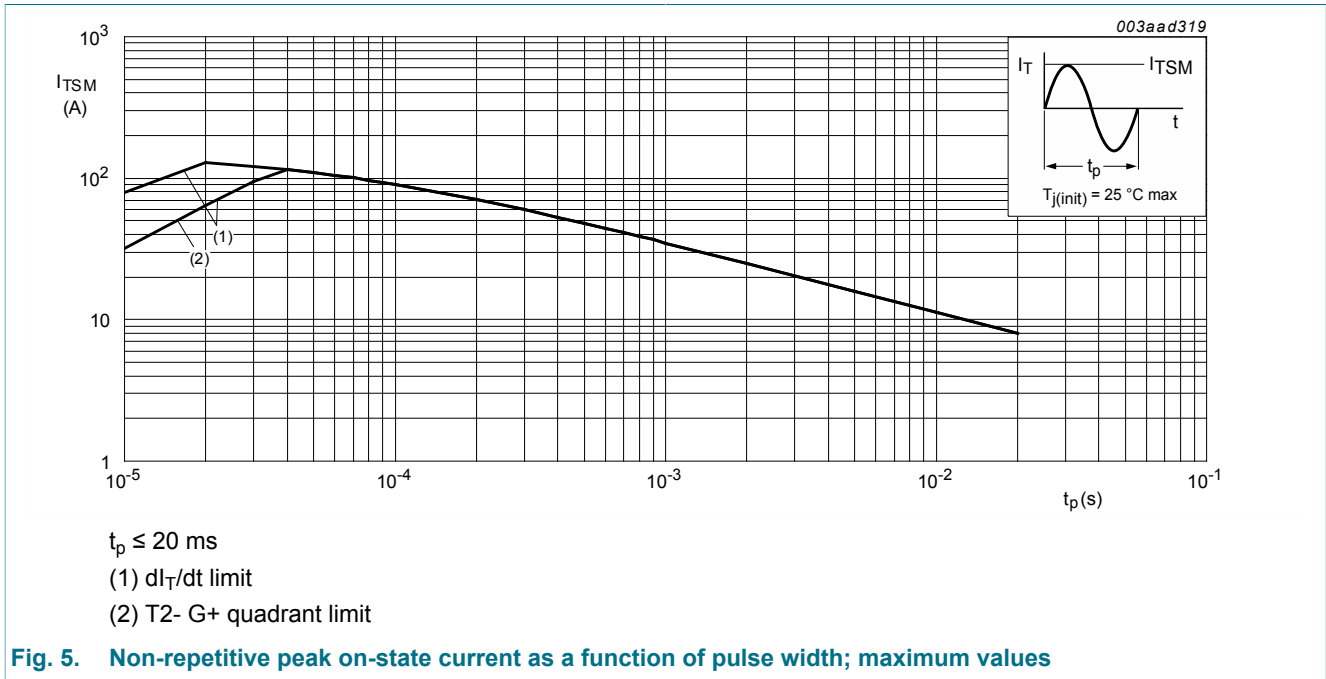
**Fig. 2. RMS on-state current as a function of surge duration; maximum values**

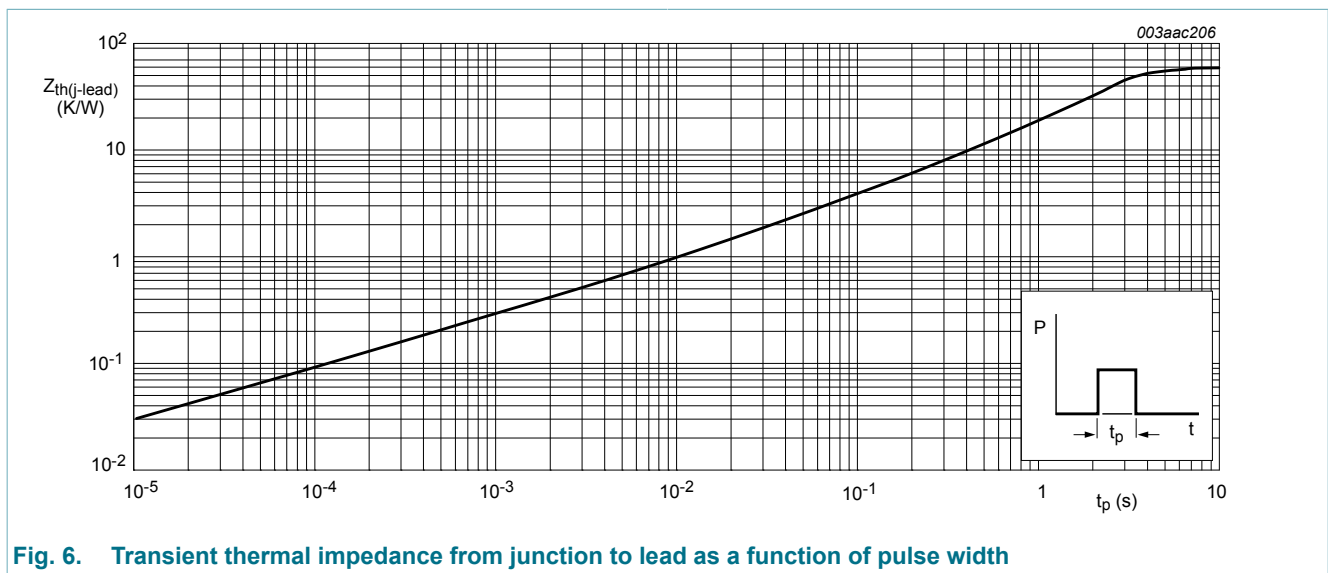

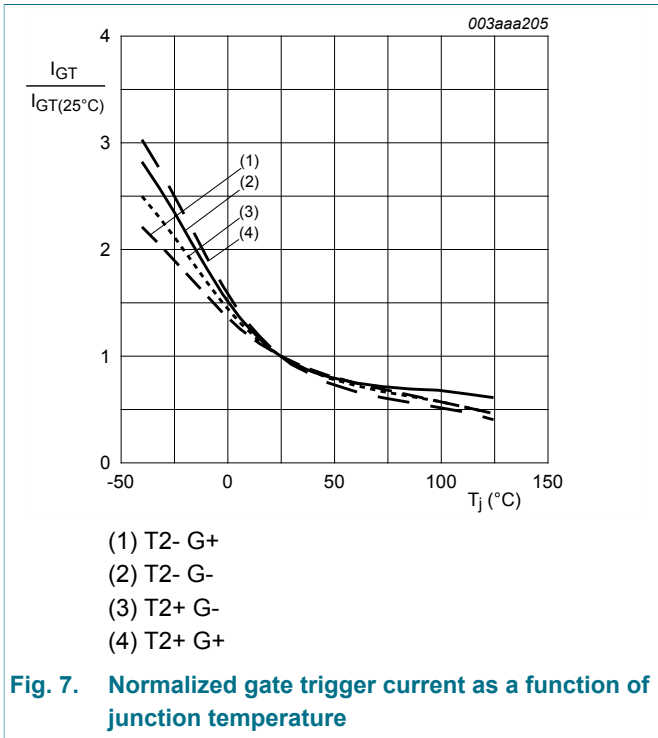

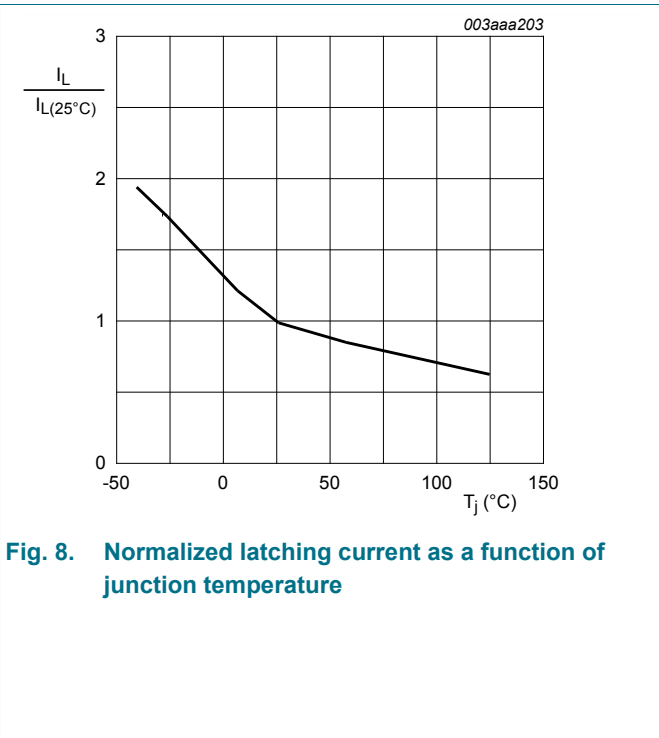

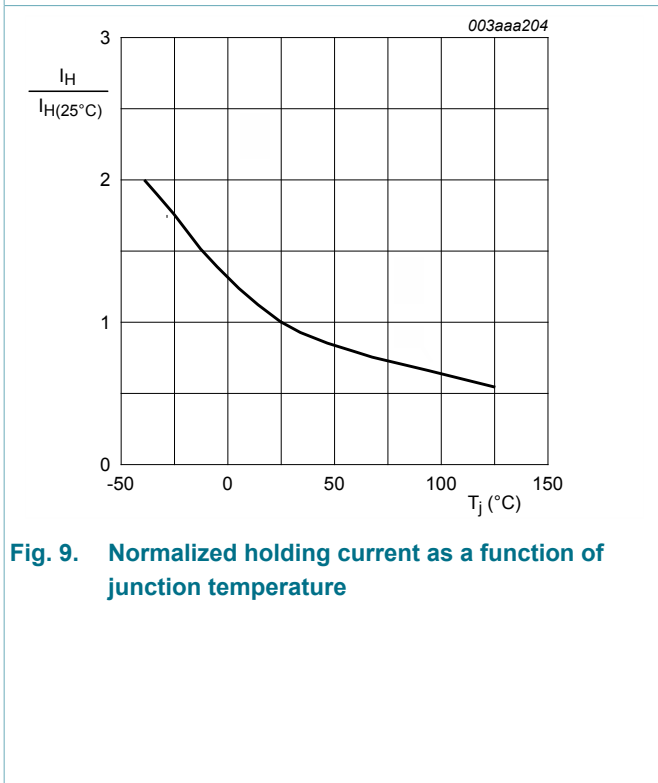

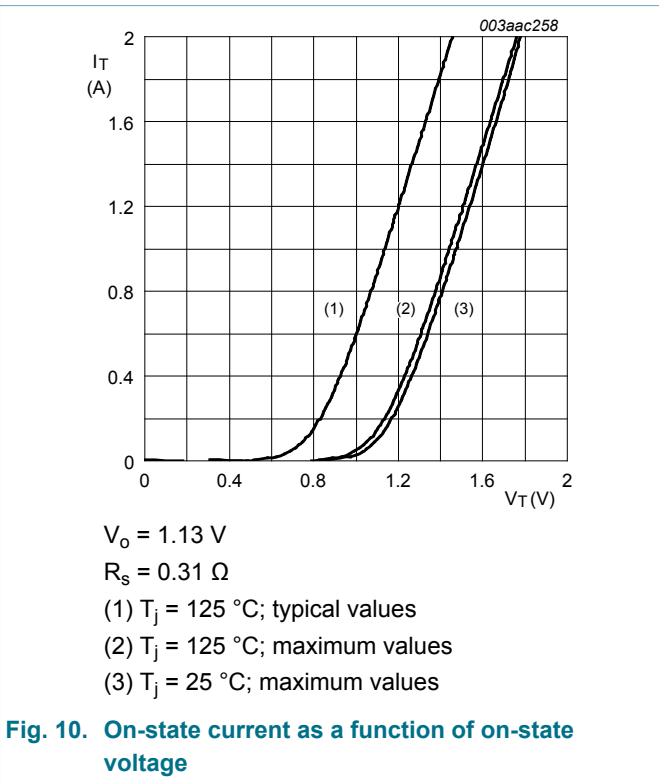
**Fig. 7. Normalized gate trigger current as a function of junction temperature**

**Fig. 9. Normalized holding current as a function of junction temperature**

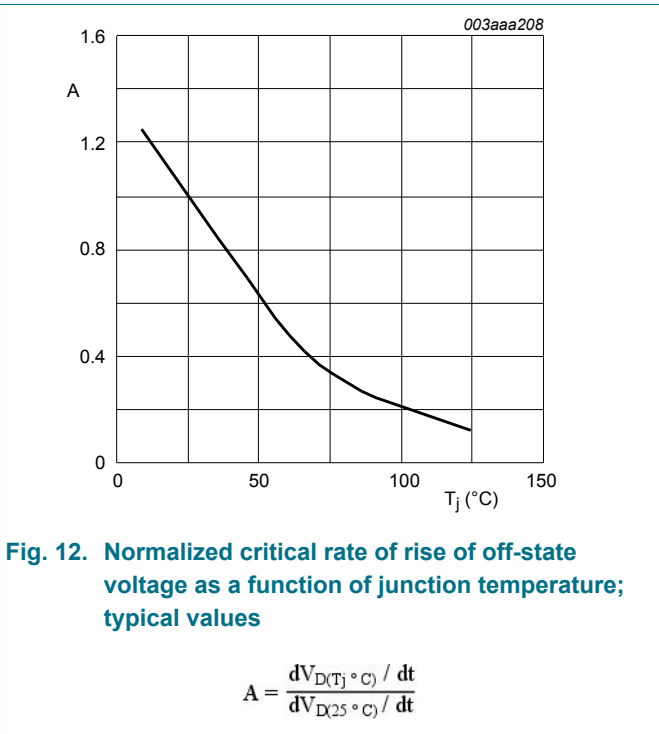
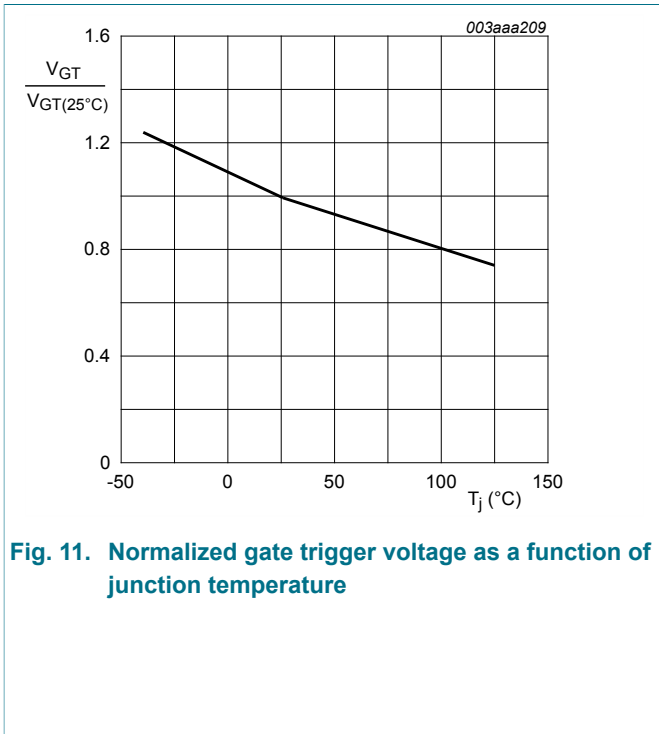


**Fig. 10. On-state current as a function of on-state voltage**

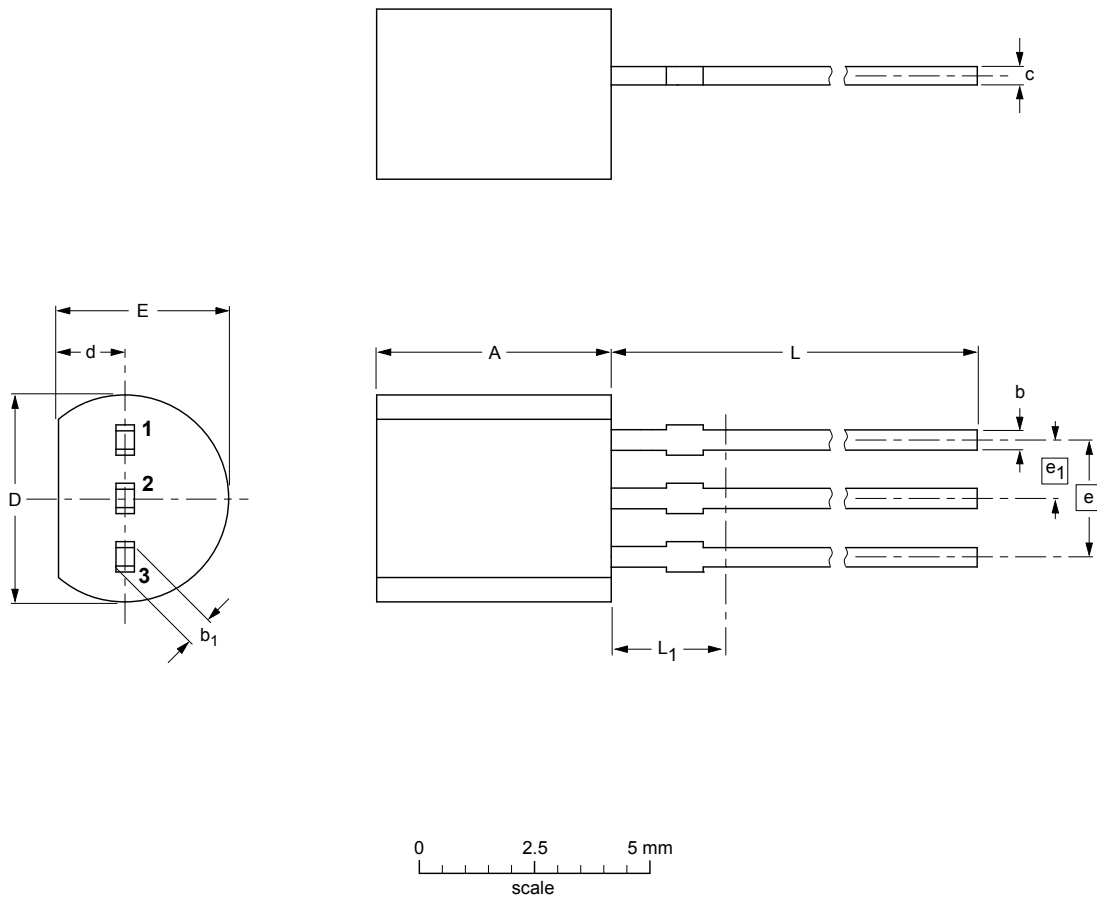
