





#### **Application Note:**

a) With the **VESD05A5A-HS3** 5 different signal or data lines can be clamped to ground. Due to the different clamping levels in forward and reverse direction the **VESD05A5A-HS3** clamping behavior is <u>Bi</u>directional and <u>Asymmetrical</u> (**BiAs**).



b) If symmetrical clamping behaviour is required the **VESD05A5A-HS3** can also be used as a <u>Bi</u>directional <u>Sy</u>mmetrical protection device protecting up to 4 lines. In this case pin no. 2 must not be connected.




Figure 1. ESD Discharge Current Wave Form acc. IEC 61000-4-2 (330  $\Omega$ /150 pF)




Figure 2. 8/20 µs Peak Pulse Current Wave Form acc. IEC 61000-4-5




Figure 3. Typical Capacitance  $C_D$  vs. Reverse Voltage  $V_R$ 




Figure 6. Typical Clamping Voltage vs. Peak Pulse Current IPP




Figure 4. Typical Forward Current I<sub>F</sub> vs. Forward Voltage V<sub>F</sub>




Figure 7. Typical Clamping Performance at + 8 kV Contact Discharge (acc. IEC 61000-4-2)




Figure 5. Typical Reverse Voltage  $V_{R}$  vs. Reverse Current  $I_{R}$ 




Figure 8. Typical Clamping Performance at - 8 kV Contact Discharge (acc. IEC 61000-4-2)





Figure 9. Typical max. Clamping Voltage at ESD Contact Discharge (acc. IEC 61000-4-2)
