




This device has CTRs tested at an LED current of 1.0 mA. This low drive current permits easy interfacing from CMOS to LSTTL or TTL.




Fig. 3 - Forward Voltage vs. Forward Current




Fig. 4 - Peak LED Current vs. Duty Factor,  $\tau$ 




Fig. 5 - Normalized CTR<sub>CE</sub> vs. LED Current




Fig. 6 - CTR vs. LED Current




Fig. 7 - Collector Current vs. LED Current




Fig. 9 - Switching Timing





Fig. 8 - Switching Schematic
