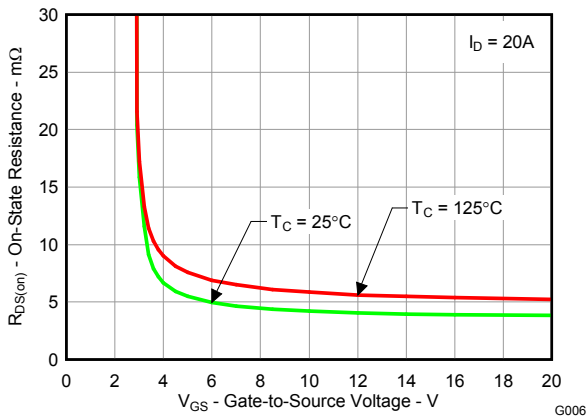

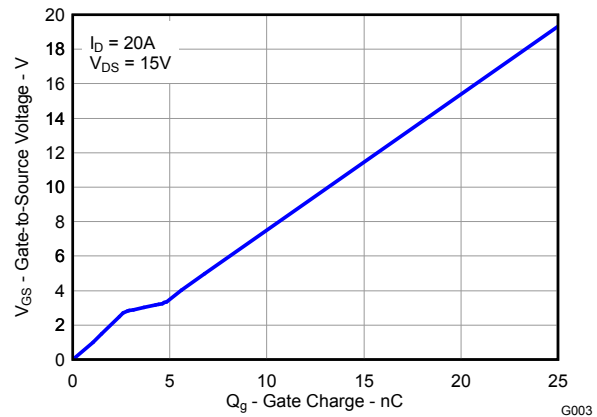

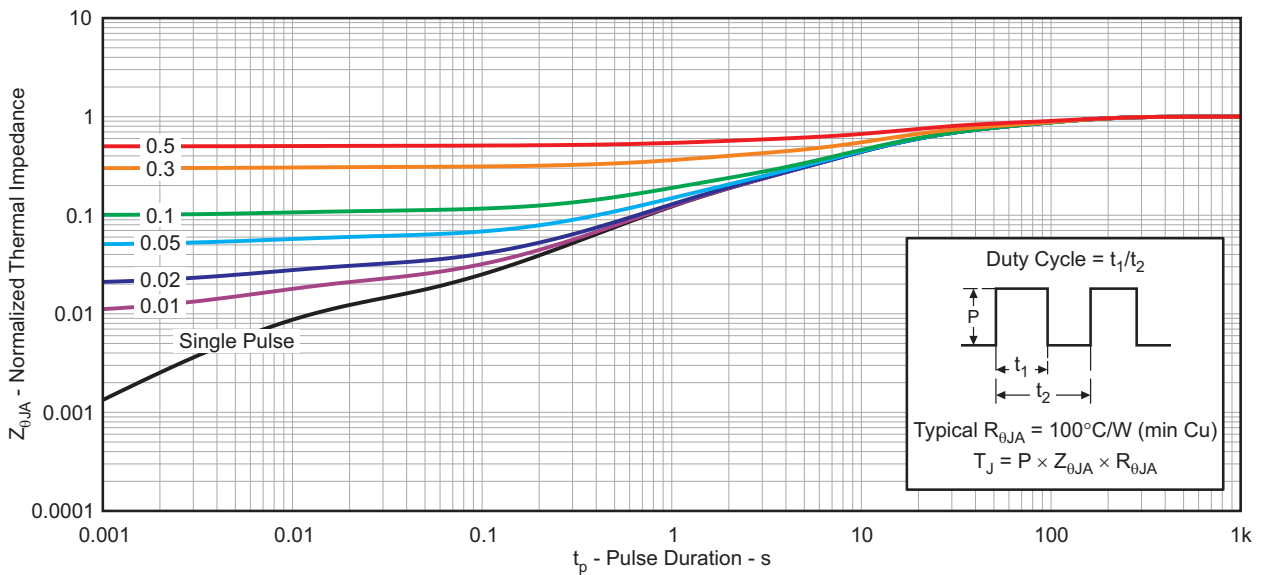


Figure 1. Transient Thermal Impedance

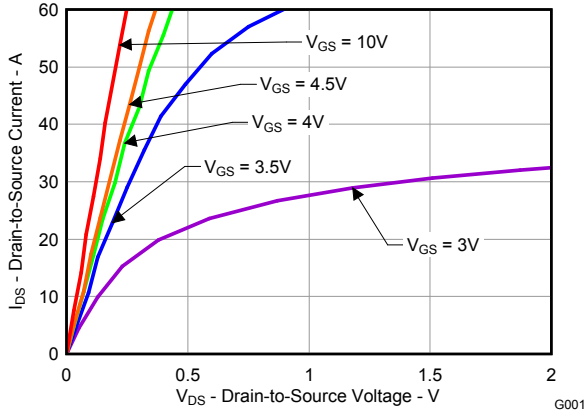

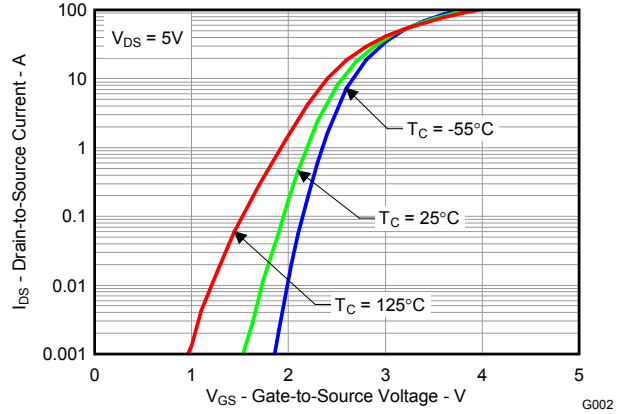

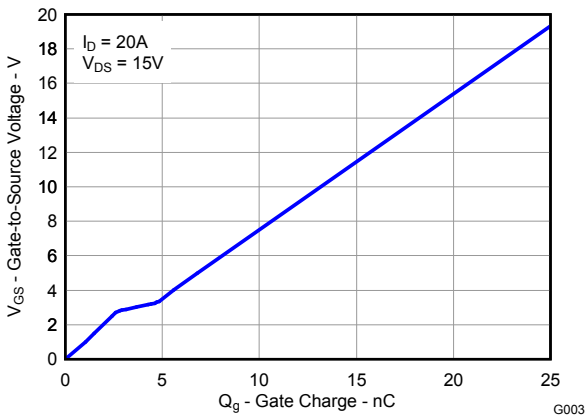

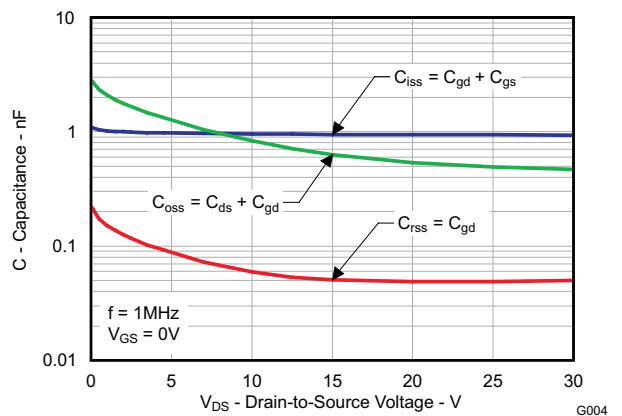
**Figure 2. Saturation Characteristics**



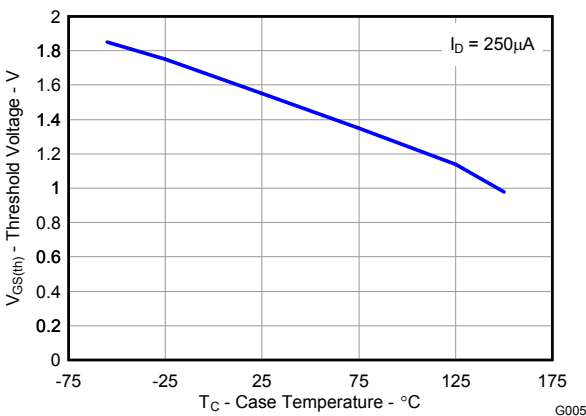
**Figure 3. Transfer Characteristics**



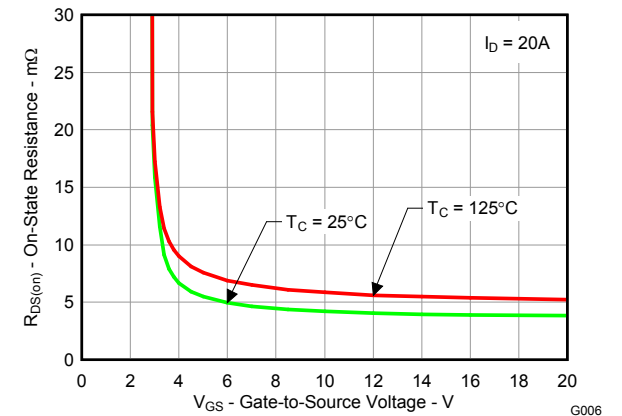
**Figure 4. Gate Charge**



**Figure 5. Capacitance**



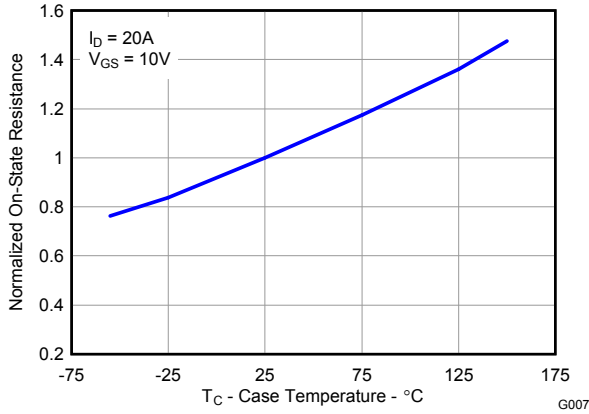
**Figure 6. Threshold Voltage vs. Temperature**



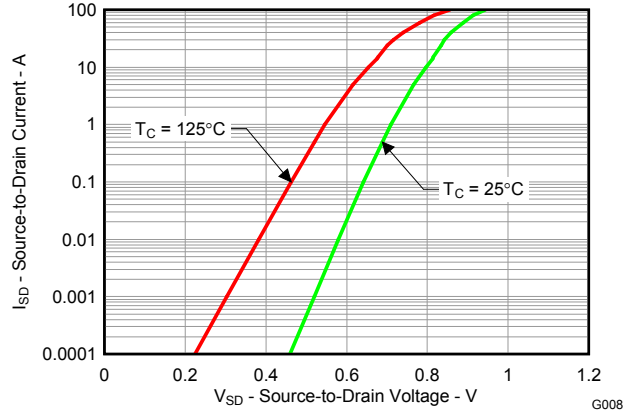
**Figure 7. On-State Resistance vs. Gate-to-Source Voltage**

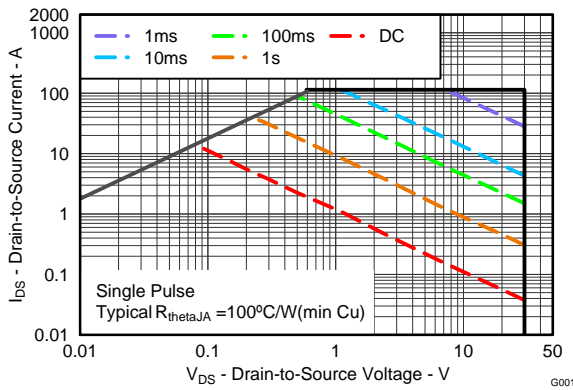

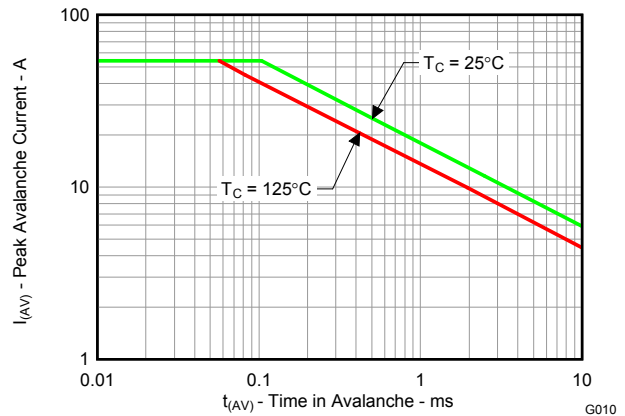
**Figure 8. Normalized On-State Resistance vs. Temperature**



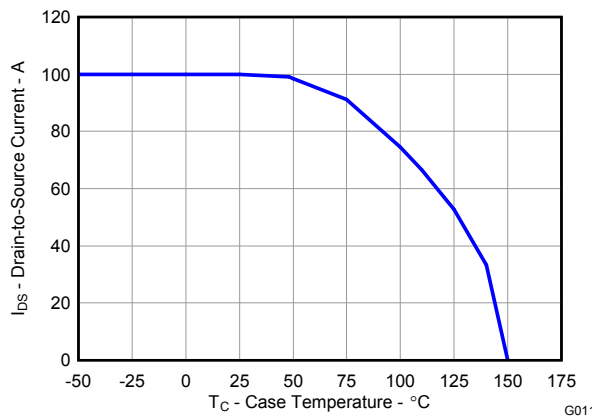
**Figure 9. Typical Diode Forward Voltage**

**Figure 12. Maximum Drain Current vs. Temperature**

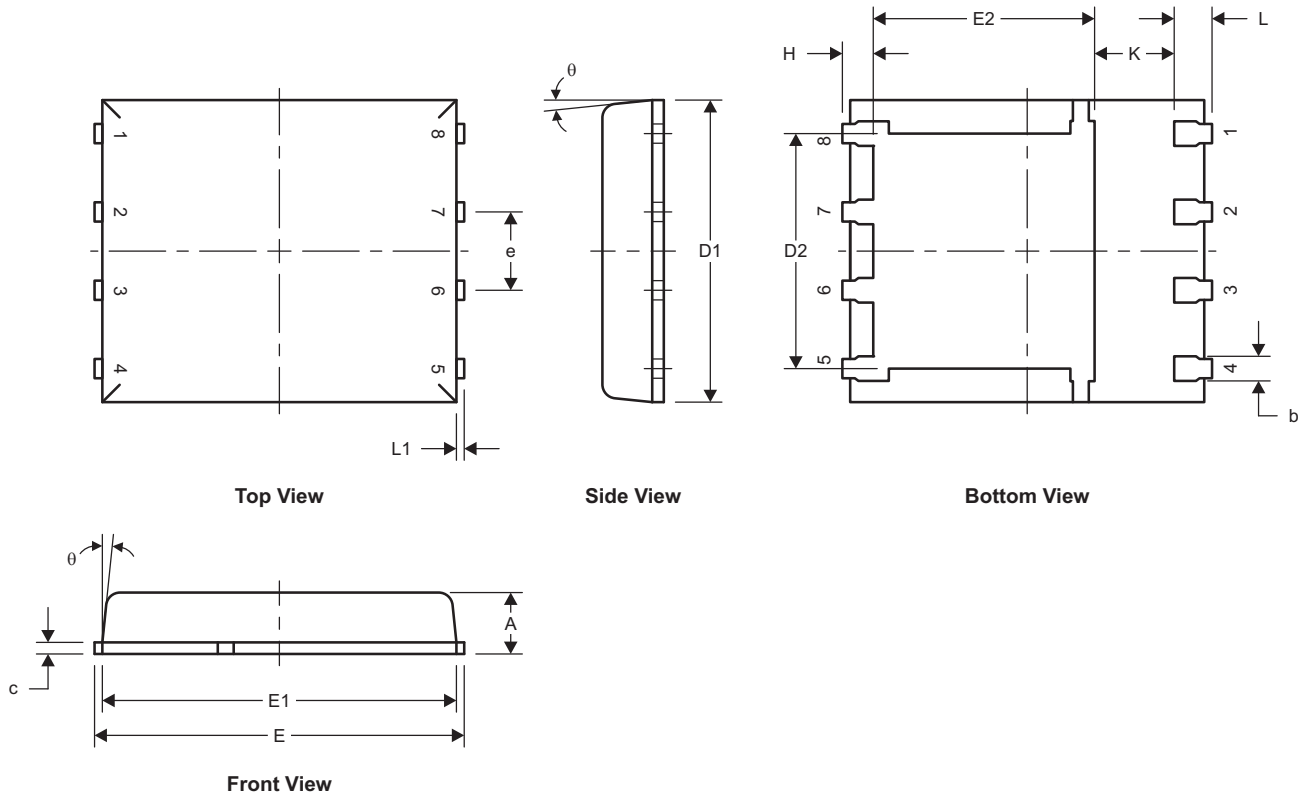

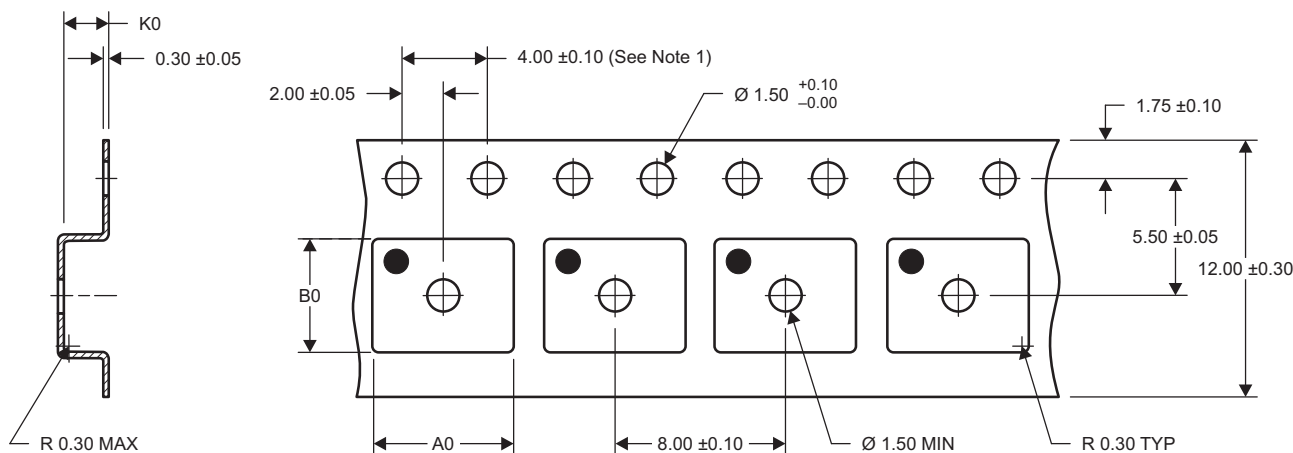
