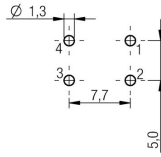


**A Dimensions: [mm]**



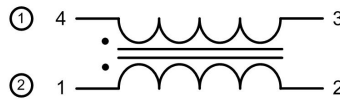
Scale - 1,5:1

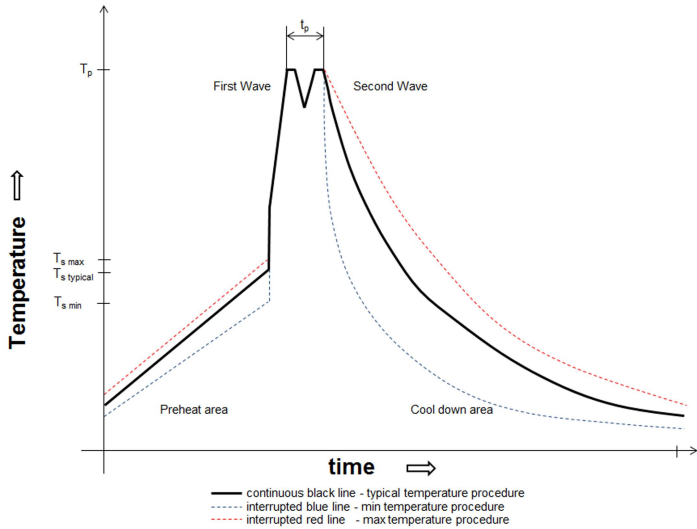
