






Top View




Fig. 6 On-Resistance Variation with Temperature


50 T<sub>A</sub>, AMBIENT TEMPERATURE (°C) Fig. 7 Gate Threshold Variation vs. Ambient Temperature







Fig. 10 Typical Drain-Source Leakage Current vs. Voltage




