

Phase Control Thyristors (Hockey PUK Version), 1350 A








Fig. 1 - Current Ratings Characteristics




Fig. 2 - Current Ratings Characteristics




Fig. 3 - Current Ratings Characteristics




Fig. 4 - Current Ratings Characteristics




Fig. 5 - On-State Power Loss Characteristics




Fig. 6 - On-State Power Loss Characteristics




Fig. 7 - Maximum Non-Repetitive Surge Current Single and Double Side Cooled




Fig. 8 - Maximum Non-Repetitive Surge Current Single and Double Side Cooled




Fig. 9 - On-State Voltage Drop Characteristics




Fig. 10 - Thermal Impedance $Z_{thJ\text{-}hs}$ Characteristics





Fig. 11 - Gate Characteristics


