



The SN74LVC2G02 performs the Boolean function  $Y = A + B$  or  $Y = \bar{A} \cdot \bar{B}$  in positive logic.

NanoFree™ package technology is a major breakthrough in IC packaging concepts, using the die as the package.

This device is fully specified for partial-power-down applications using  $I_{off}$ . The  $I_{off}$  circuitry disables the outputs, preventing damaging current backflow through the device when it is powered down.


