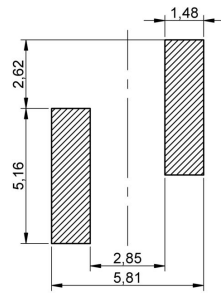

F1 Typical Inductance vs. Frequency Characteristics:



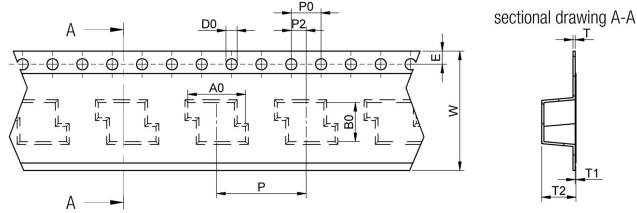
F2 Typical Q-factor vs. Frequency Characteristics:



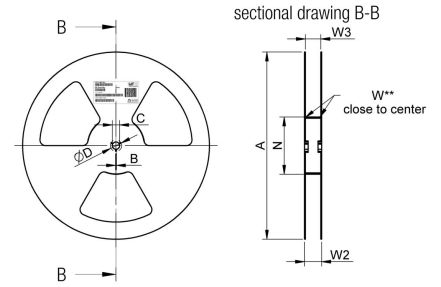
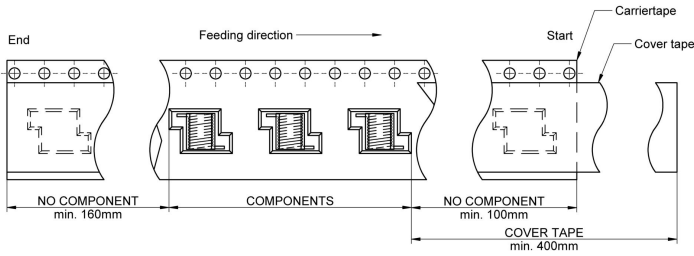

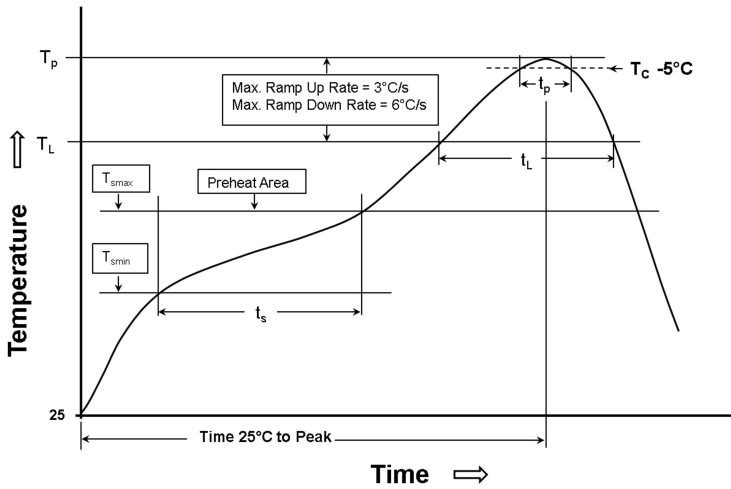
