




## Forward Current vs. Collector Dissipation Temperature Rating




Relative Light Current vs. Ambient Temperature Characteristics (Typical)



Response Time vs. Load Resistance Characteristics (Typical)




Relative Collector Current vs. Card Moving Distance (2)




# **Light Current vs. Forward Current Characteristics (Typical)**




Dark Current vs. Ambient Temperature Characteristics (Typical)




**Sensing Distance Characteristics** (Typical)



### Response Time Measurement Circuit




### Light Current vs. Collector–Emitter Voltage Characteristics (Typical)




Collector–Emitter voltage V<sub>CE</sub> (V)
