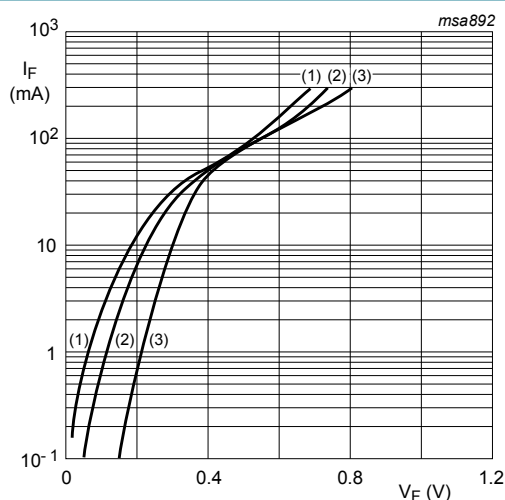

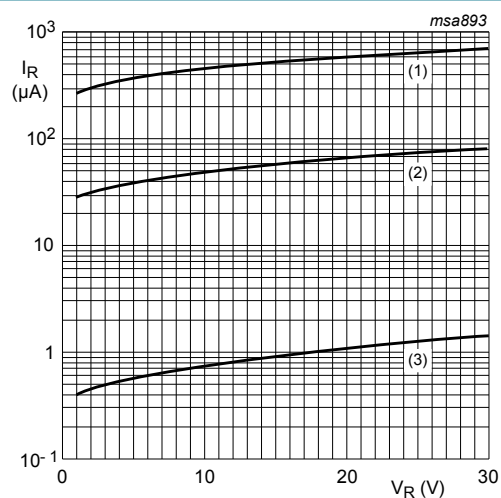

Fig. 1. Forward current as a function of forward voltage; typical values



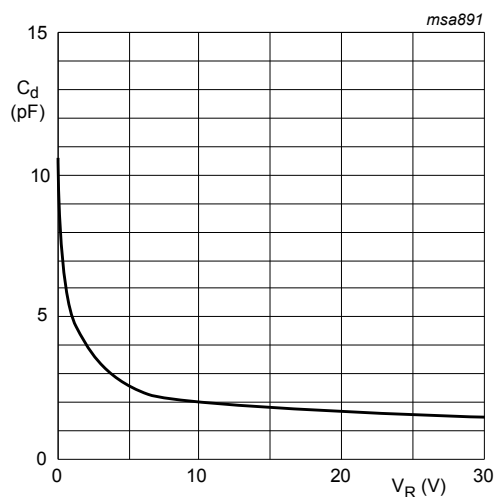

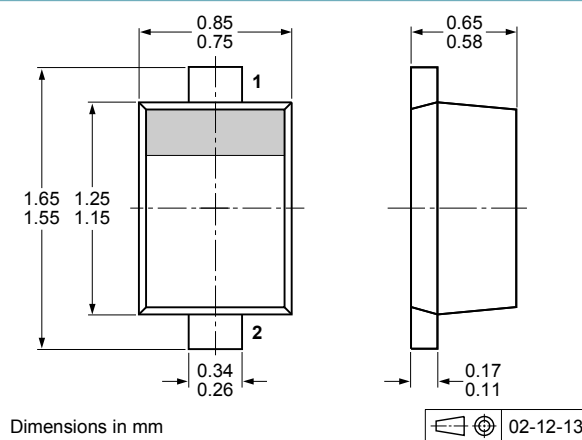


Fig. 4. SOD523

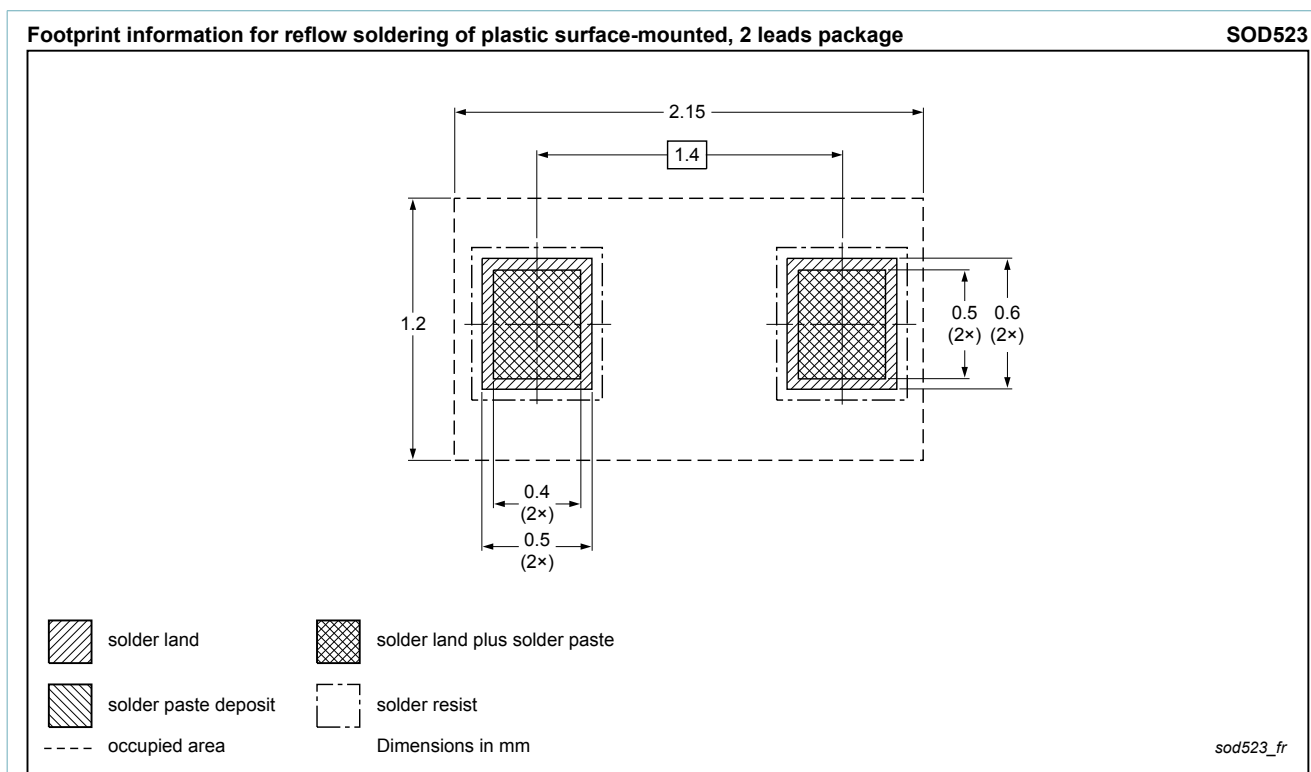


Fig. 5. Reflow soldering footprint for SOD523 (SOD523)
