### Description

The H-183 Hand Dispenser provides a quick and easy method for dispensing "Scotch" brand Film Box Sealing Tapes directly from the roll. This hand-held portable dispenser is recommended for center seam sealing of RSC boxes.

### Specifications

**Tape:** Most "Scotch" brand Film Box Sealing Tapes.

**Tape Width:** 3 inch or 72 mm maximum.

**Tape Roll Diameter:** Up to 5 1/8 inch [130 mm] maximum on a 3 inch [76,2 mm] diameter core.

Length: 5 3/4 inches [145 mm]

Height: 10 inches [255 mm]

Width: 3 3/4 inches [95 mm]

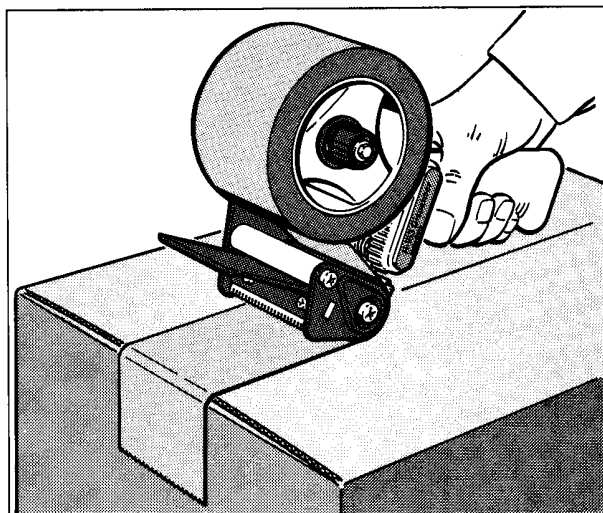

### Loading Instructions

**Figure 1** — Place tape roll fully onto tape drum to dispense tape forward from top of roll. Pull tab to remove and discard blade protection.

**Figure 2** — Pivot brake to open position. Thread tape between roller and brake.

**Figure 3** — Bring tape up around roller and pull back, slightly to one side, to cut off excess tape. Adjustable tape roll tension provided.



H-183 Hand Dispenser, Model 29000

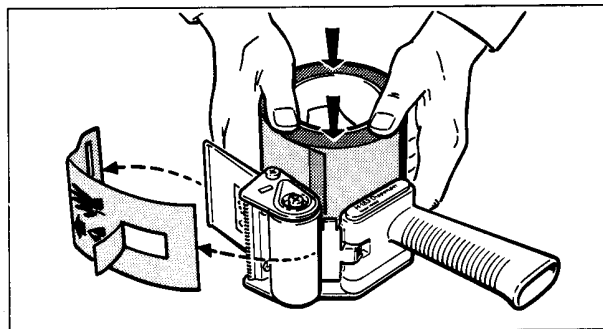

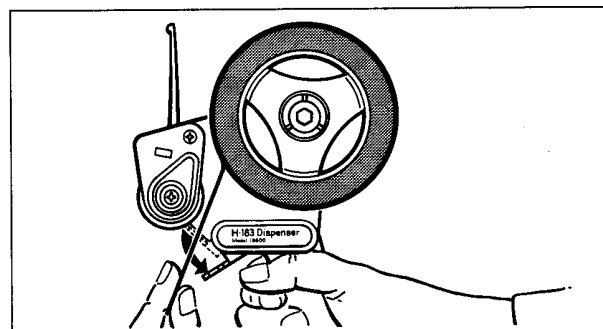

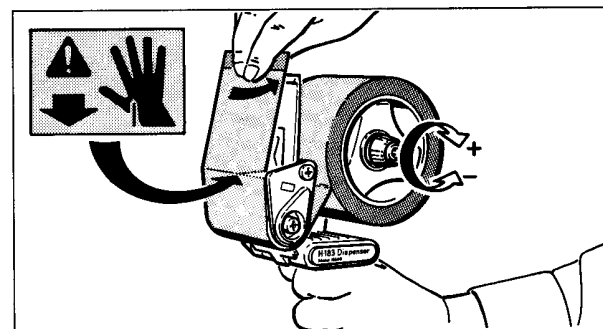
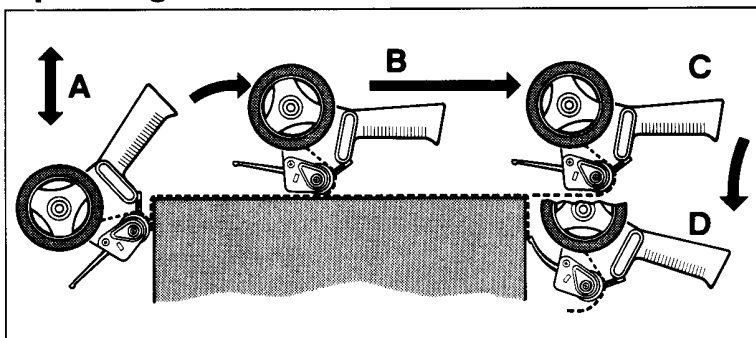

## Operating Instructions



A. Place tape and applicator roller on box front corner, centered on top seam. Roll dispenser down to tack tape lead end to side of box.

B. Pull dispenser across box top seam, applying pressure to applicator roller to obtain a tight seal.

C. Continue tape web 2-1/2 to 3 inches or 65 to 75 mm past end of box.

D. Bring dispenser tape wipe-down plate against corner of box, push down and twist slightly to cut and wipe tape end to back side of box.

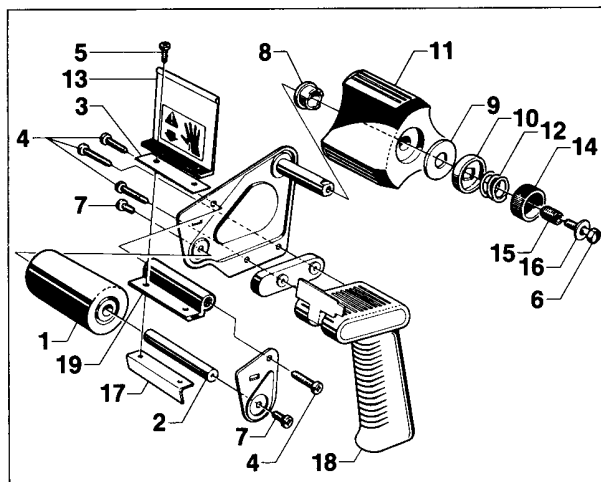

## How To Replace The Blade

**WARNING:** - Use care when working near the blade as the blade is sharp.

1. Remove blade screws and nuts to remove used blade.
2. Install replacement blade with serrated cutting edge pointing away from applicator roller.
3. Replace and tighten blade screws and nuts to secure blade.
