

CIRCUIT DESIGN NOTES


1. Protective current-limiting resistors may be necessary to operate the Displays.


Reflow Soldering Profile For Lead-free SMT Process.




NOTES:

1. We recommend the reflow temperature 245°C (+/-5°C). The maximum soldering temperature should be limited to 260°C.
2. Don't cause stress to the epoxy resin while it is exposed to high temperature.
3. Number of reflow process shall be 2 times or less.


Recommended Soldering Pattern (Units : mm; Tolerance: ± 0.15)



Reel Dimension




Tape Specifications (Units : mm)








Inside Label on Tape




Outside Label on Bag
