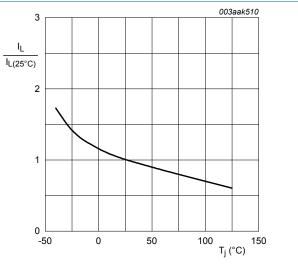


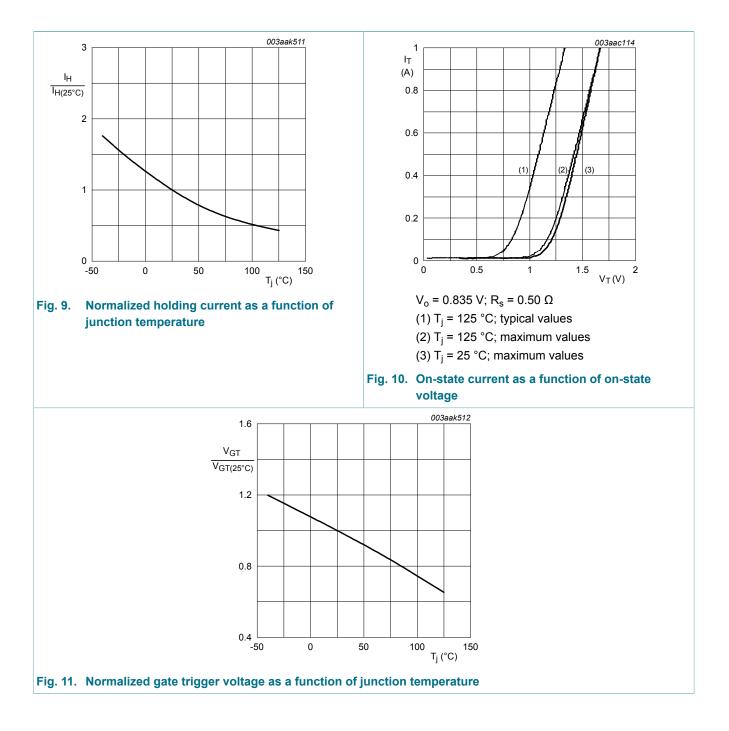
Fig. 8. Normalized latching current as a function of junction temperature

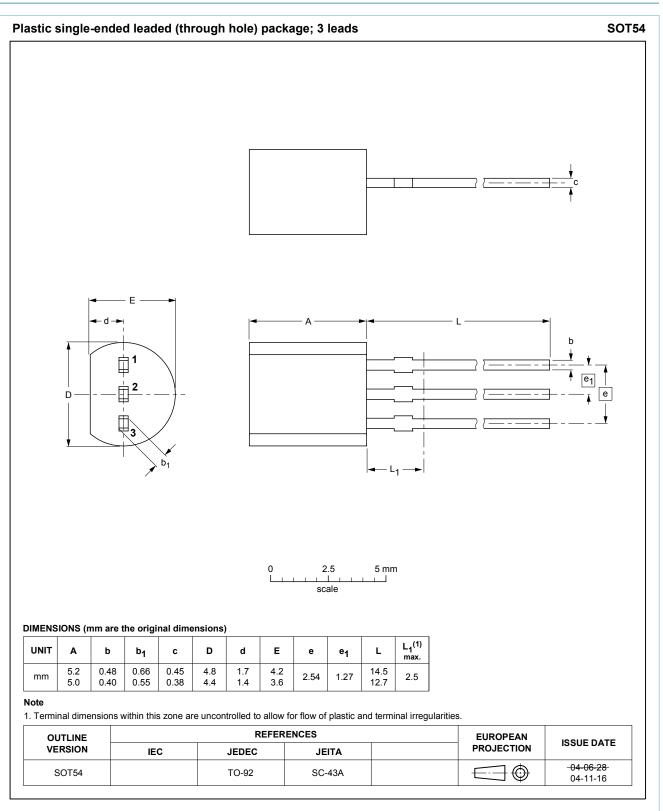


Fig. 12. Package outline TO-92 (SOT54)
