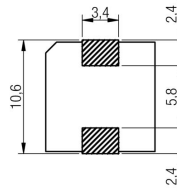

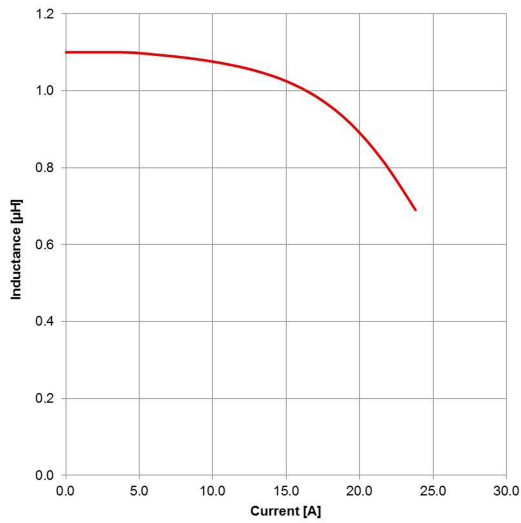

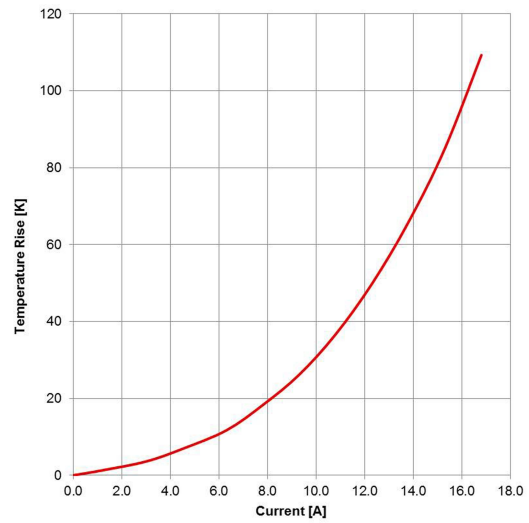

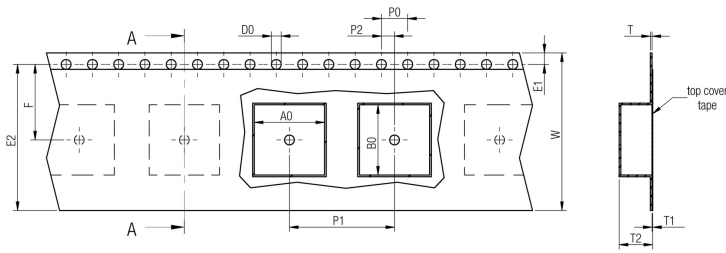
F3 Typical Impedance Characteristics:



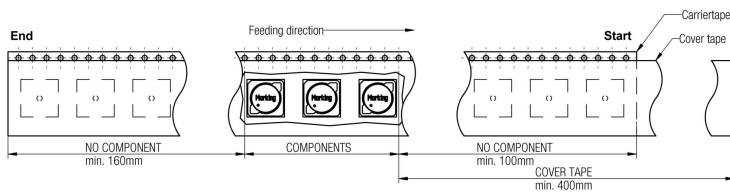
