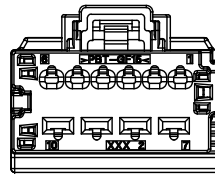

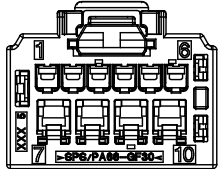
POLARIZATION OPTION A

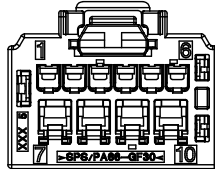
POLARIZATION OPTION B

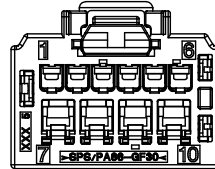

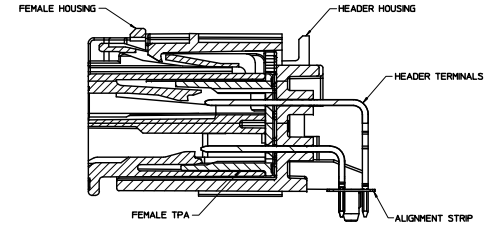

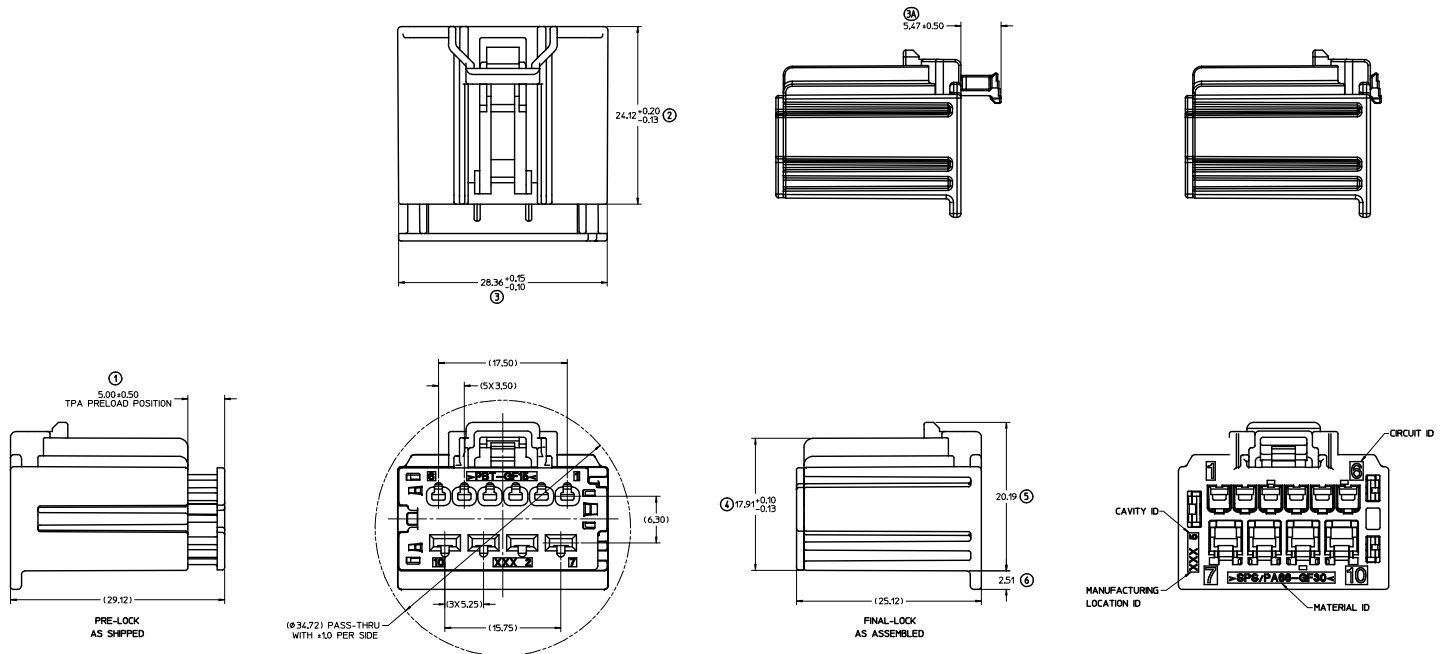
