


#### **PACKAGE DIMENSIONS (in millimeters)**










## FORWARD VOLTAGE vs. AMBIENT TEMPERATURE




## OFF-STATE LEAKAGE CURRENT vs. APPLIED VOLTAGE




MAXIMUM LORD CURRENT vs. AMBIENT TEMPERATURE

#### LORD CURRENT vs. LORD VOLTAGE






#### NORMALIZED ON-STATE RESISTANCE vs. AMBIENT TEMPERATURE




#### ON-STATE RESISTANCE DISTRIBUTION




#### TURN-ON TIME vs. FORWARD CURRENT




TURN-OFF TIME vs. FORWARD CURRENT



#### TURN-ON TIME DISTRIBUTION




TURN-OFF TIME DISTRIBUTION




## NORMALIZED TURN-OFF TIME vs. AMBIENT TEMPERATURE


