





Average forward current versus ambient temperature  $(\delta = 0.5, \text{ per diode})$ 







Figure 3. Normalized avalanche power derating versus pulse duration

Figure 4. Normalized avalanche power derating versus junction temperature








Figure 5. Non repetitive surge peak forward current versus overload duration (maximum values, per diode)

Figure 6. Relative variation of thermal impedance junction to ambient versus pulse duration










