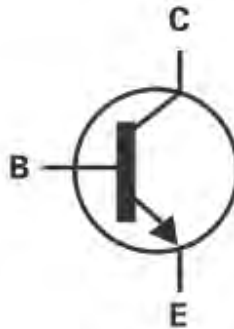

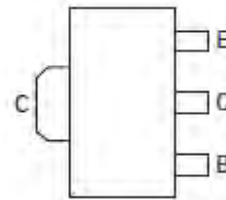

Device symbol



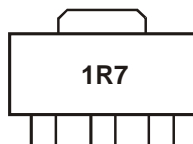
Top View

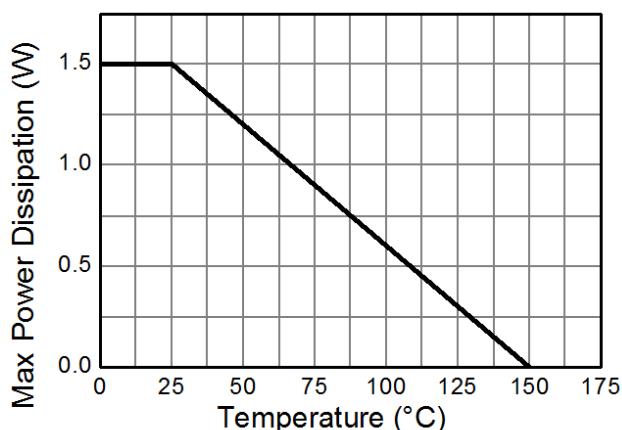

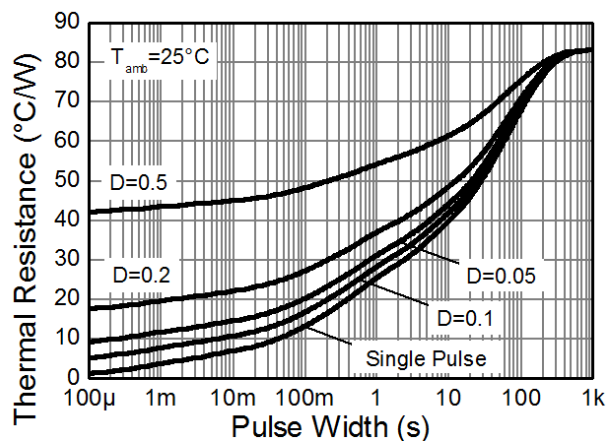

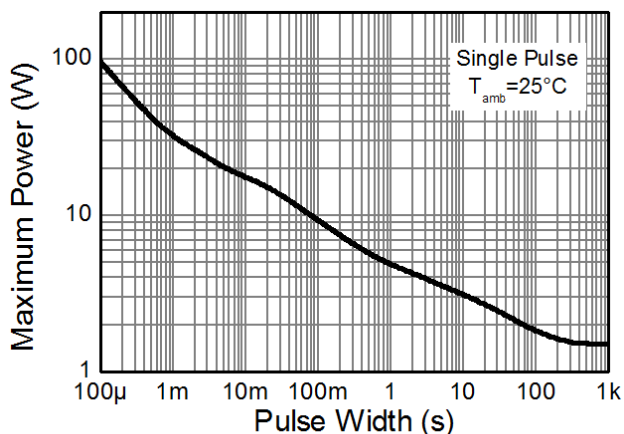

Transient Thermal Impedance



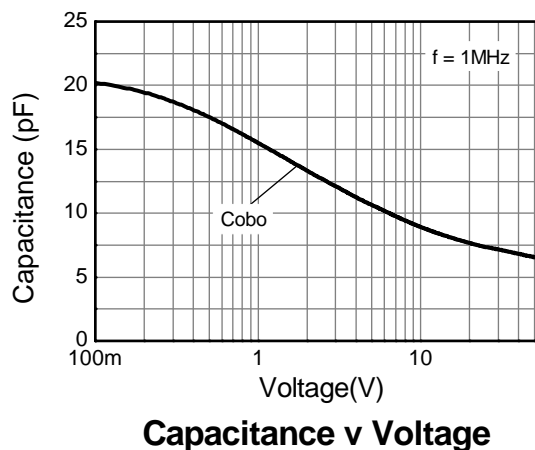
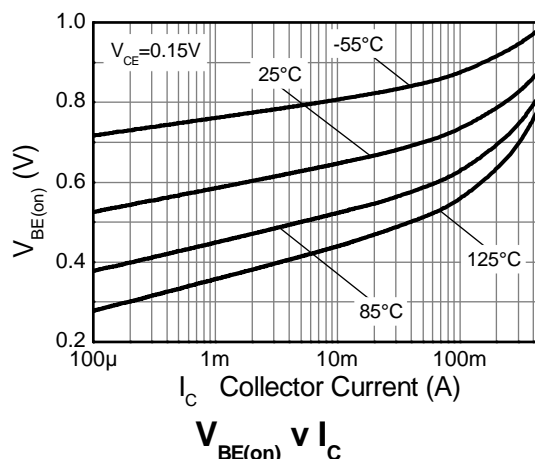
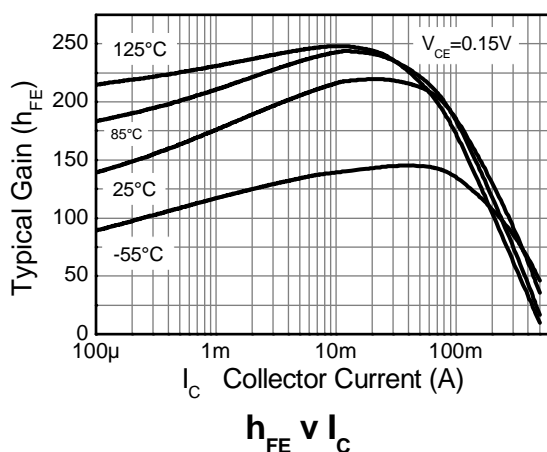

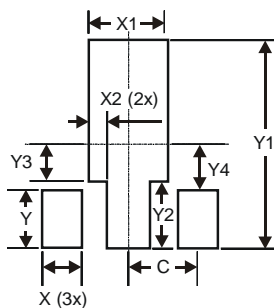
