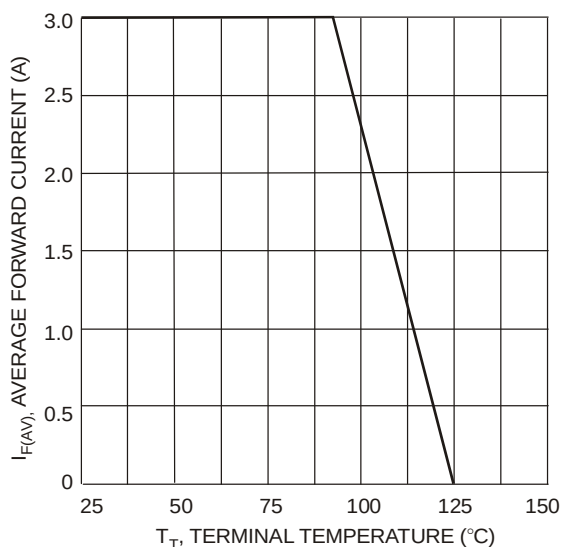


Fig. 3 Forward Current Derating Curve

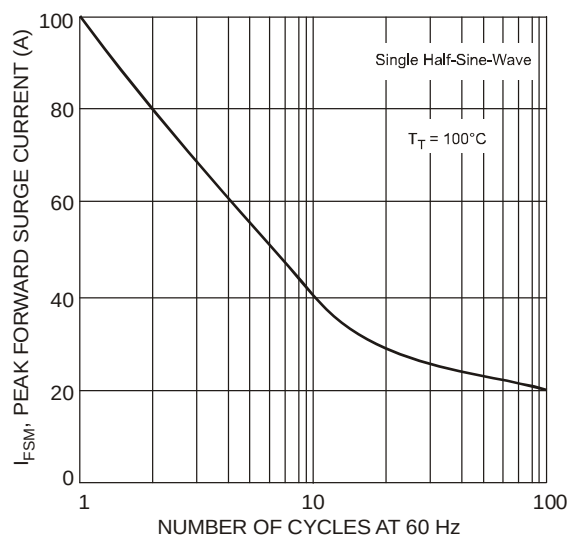
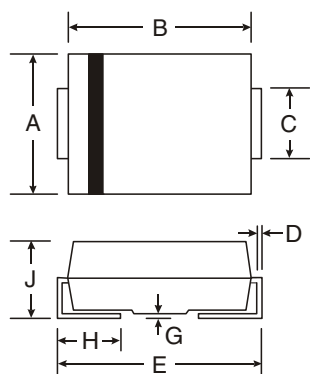


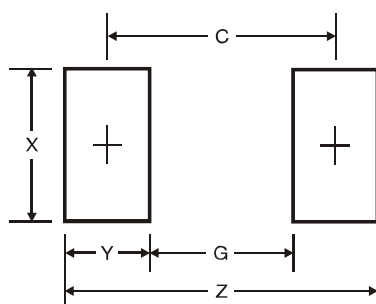
Fig. 4 Max Non-Repetitive Peak Forward Surge Current
