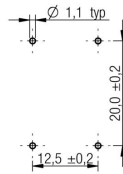

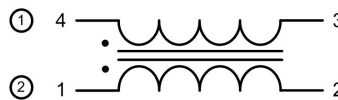





F Typical Insertion Loss Characteristics:

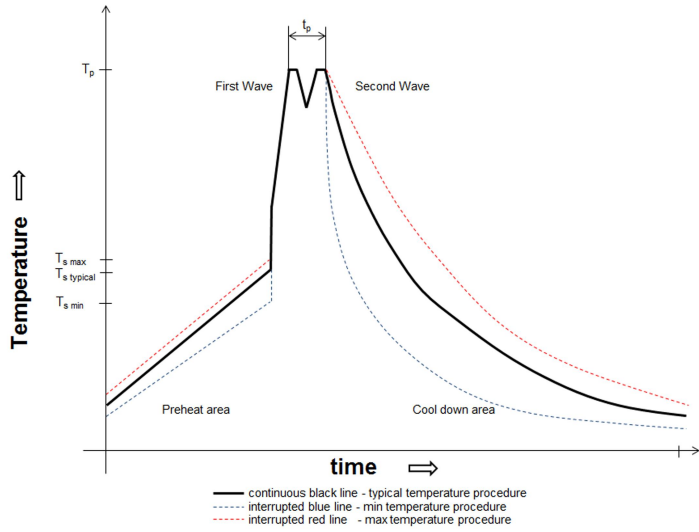



Product specific:


