## A Dimensions: [mm]



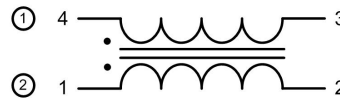





## F Typical Insertion Loss Characteristics:

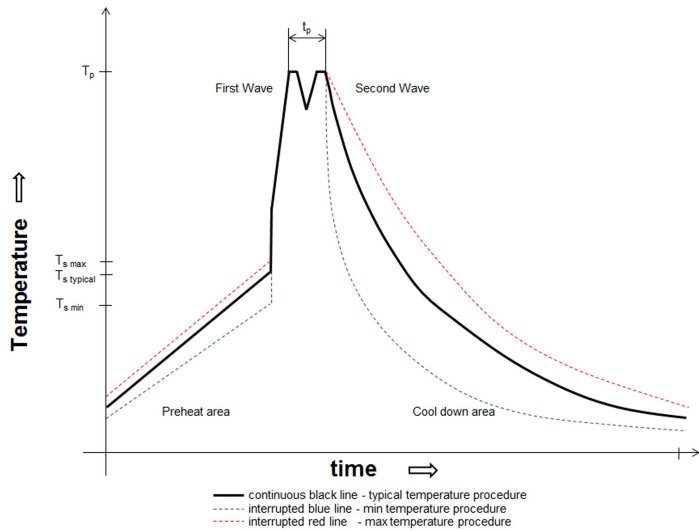


