








# vs. AMBIENT TEMPERATURE


TRANSISTOR POWER DISSIPATION




# FORWARD CURRENT vs. FORWARD VOLTAGE




COLLECTOR CURRENT vs.

# COLLECTOR TO EMITTER DARK CURRENT vs. AMBIENT TEMPERATURE




# COLLECTOR CURRENT vs. COLLECTOR SATURATION VOLTAGE






# NORMALIZED CURRENT TRANSFER RATIO vs. AMBIENT TEMPERATURE




# FREQUENCY RESPONSE




# CURRENT TRANSFER RATIO vs. FORWARD CURRENT



### SWITCHING TIME vs. LOAD RESISTANCE




#### LONG TERM CTR DEGRADATION



Avoid removing the residual flux with freon-based and chlorine-based cleaning solvent.

#### 2. Cautions regarding noise

Be aware that when voltage is applied suddenly between the photocoupler's input and output or between corrector-emitters at startup, the output side may enter the on state, even if the voltage is within the absolute maximum ratings.
