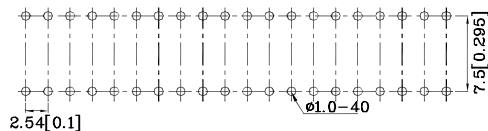

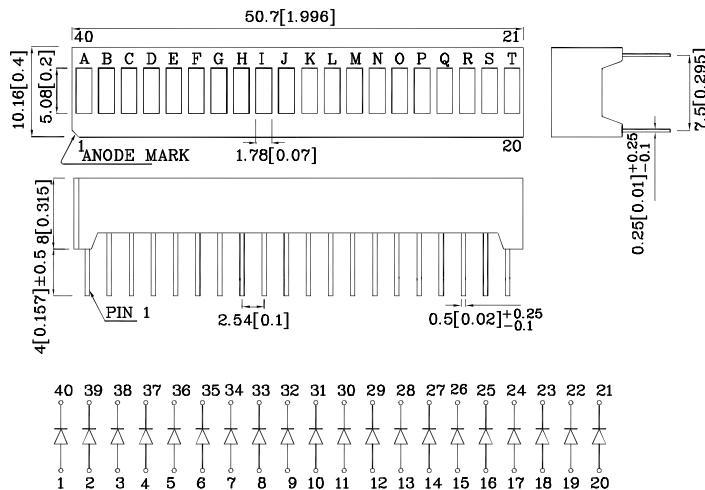

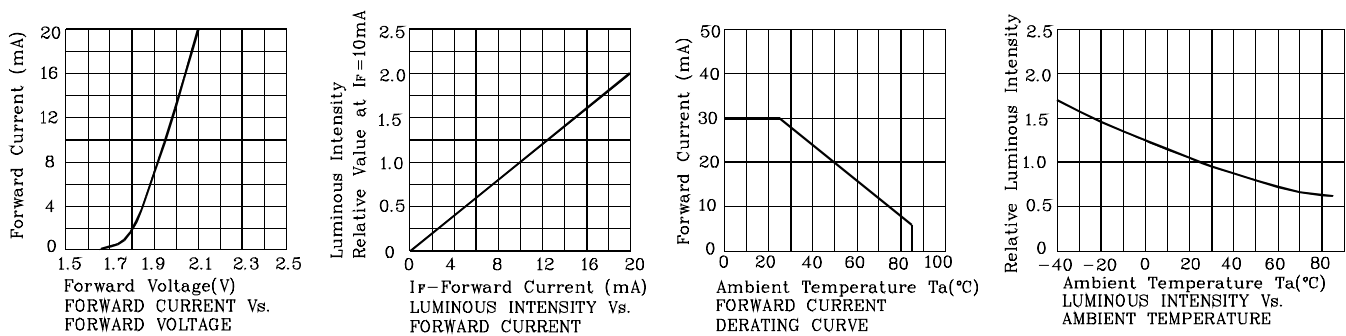

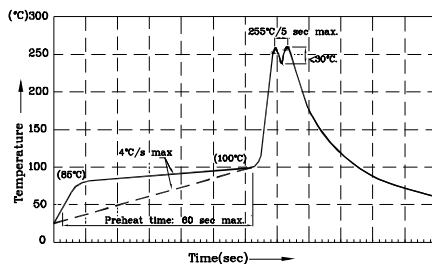
XDSA1923 V8-X Layout: Maggie L.

Wave Soldering Profile for Thru-Hole Products (Pb-Free Components)



- Notes:
1. Recommend pre-heat temperature of 105 $^\circ\text{C}$  or less (as measured with a thermocouple attached to the LED pins) prior to immersion in the solder wave with a maximum solder bath temperature of 250 $^\circ\text{C}$ .
  2. Peak wave soldering temperature between 245 $^\circ\text{C}$  ~ 255 $^\circ\text{C}$  for 3 sec (5 sec max).
  3. Do not apply stress to the epoxy resin while the temperature is above 85 $^\circ\text{C}$ .
  4. Fixtures should not incur stress on the component when mounting and during soldering process.
  5. SAC 305 solder alloy is recommended.
  6. No more than one wave soldering pass.

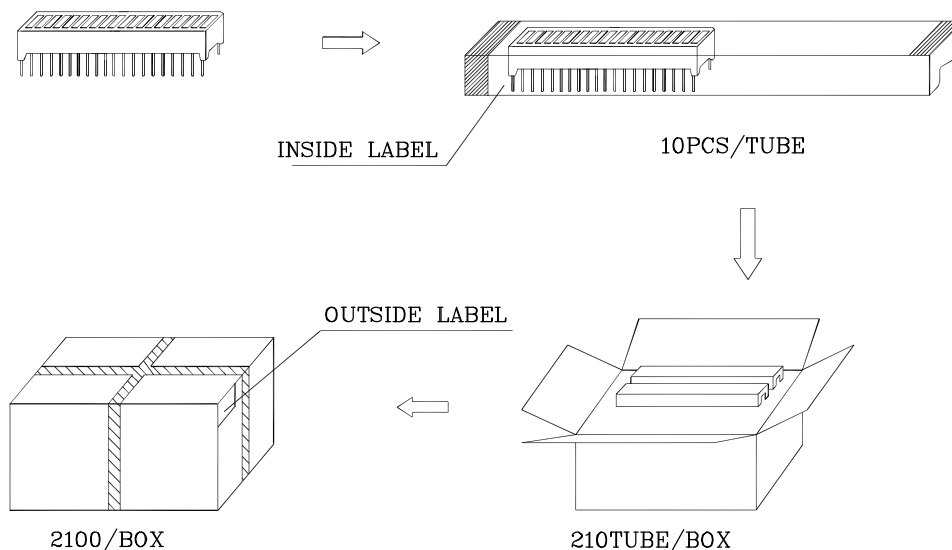
Remarks:

If special sorting is required (e.g. binning based on forward voltage, luminous intensity / luminous flux, or wavelength), the typical accuracy of the sorting process is as follows:

1. Wavelength:  $\pm 1\text{nm}$
2. Luminous Intensity / Luminous Flux:  $\pm 15\%$
3. Forward Voltage:  $\pm 0.1\text{V}$

Note: Accuracy may depend on the sorting parameters.
