B Recommended land pattern: [mm]



F3 Forward Current vs. Forward Voltage:







F6 Chromaticity diagram:





A single bin cannot be ordered. Please contact us in advance, if you need a particular bin sorting before placing your order to clarify the lead time, MOQ and pricing.



Product specific:

Follow all instructions mentioned in the data sheet, especially:

- The soldering profile has to be complied with according to the technical reflow/ or wave soldering specification, otherwise this will void the warranty.
