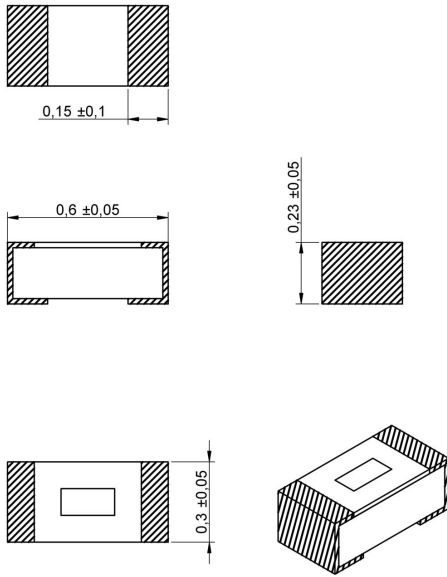

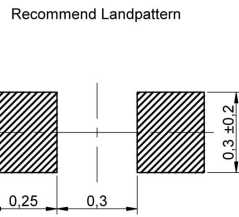

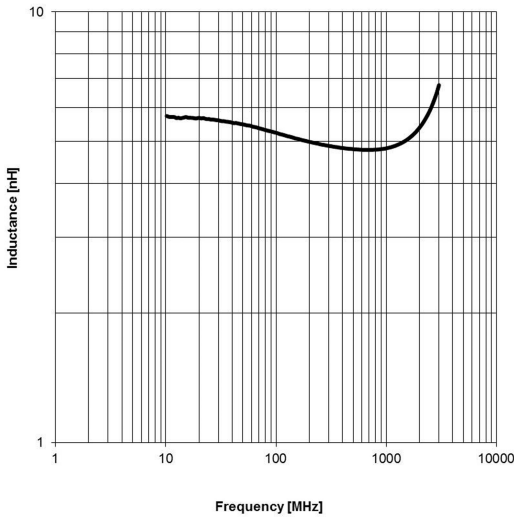

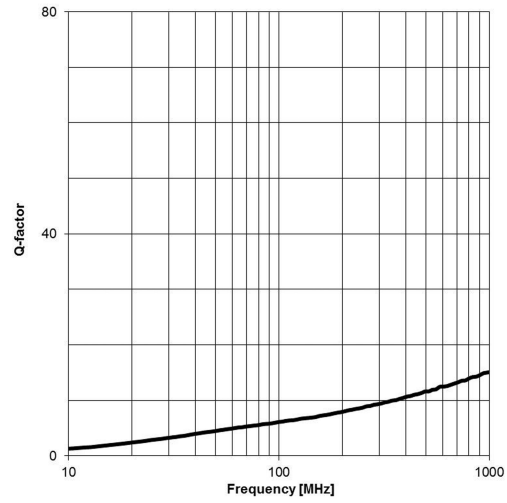

F2 Typical Q-factor vs. Frequency Characteristics:



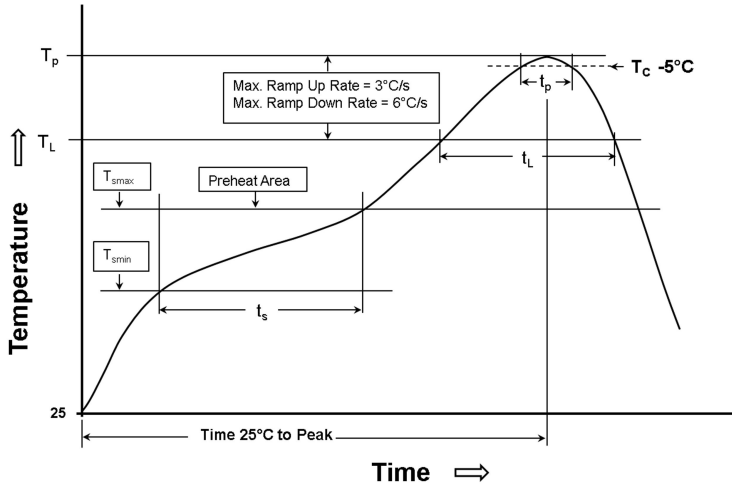
