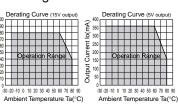

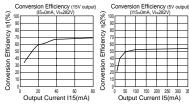

Derating Curve

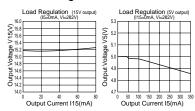

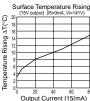


Load Regulation
